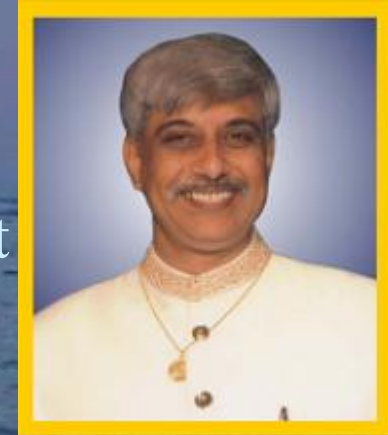

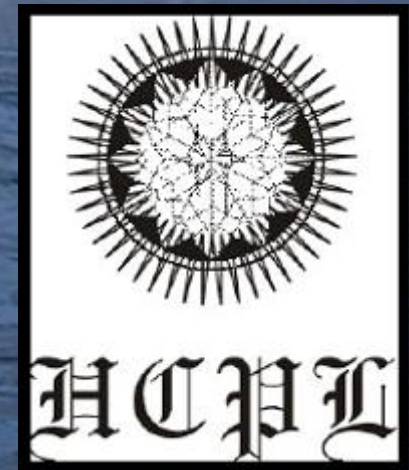

Limitations of Modern Medicine!

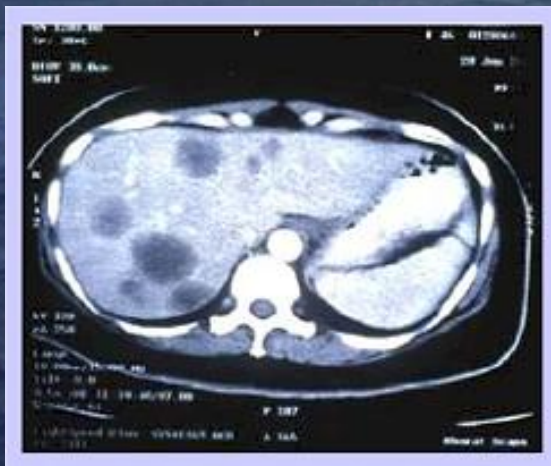
Dealing with Cancer

- ý Meningioma of the Brain, treated with a combination of Surgery and Pranic Healing.

- ý Adenocarcinoma of the liver was treated with a combination of Chemotherapy and Pranic Healing

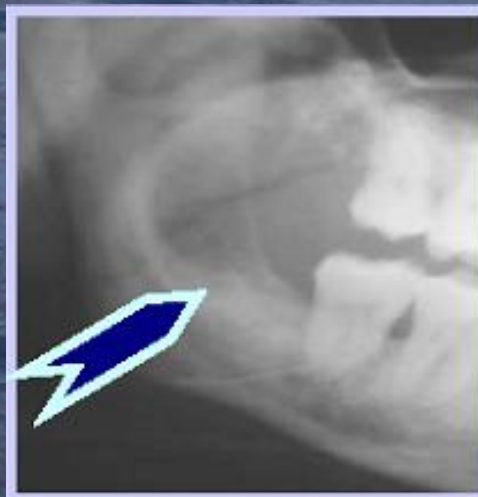

Regeneration – Bony Tissues

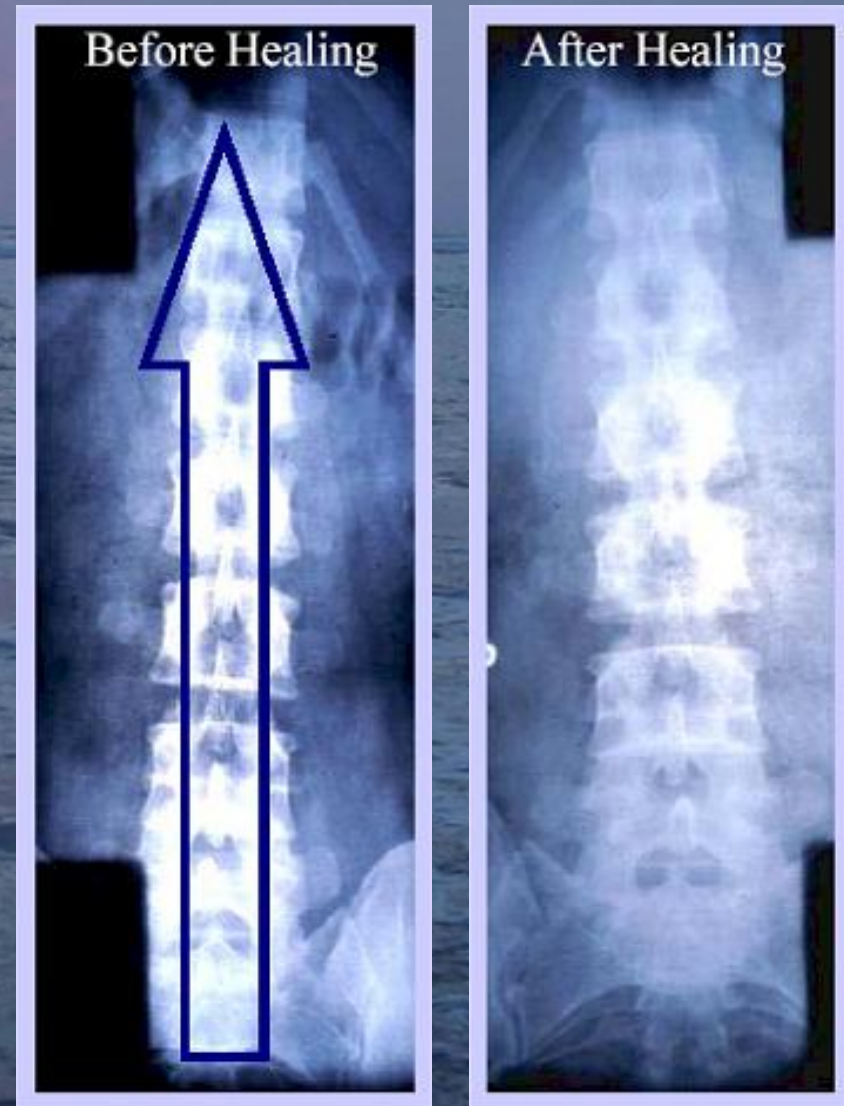

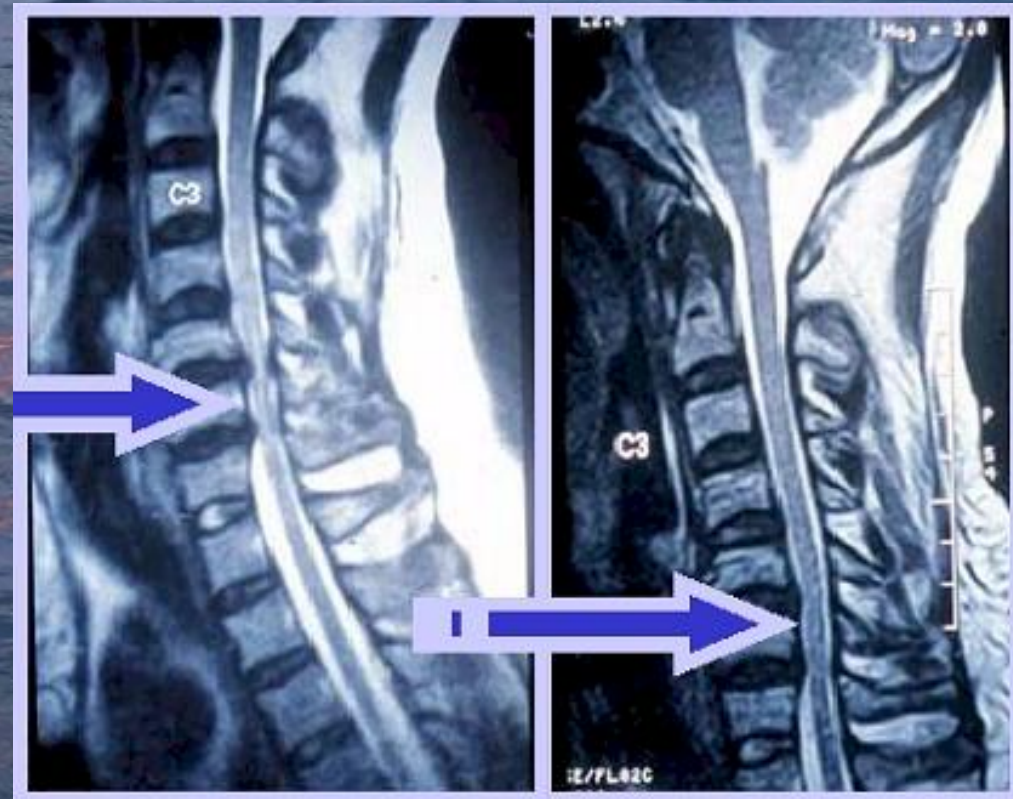
Regeneration – Spine

- ý A case of scoliosis with osteophytes and degeneration of the inter-vertebral discs.

- ý Observable realignment of discs relieving the impinged spinal chord.




Regeneration – Special Senses

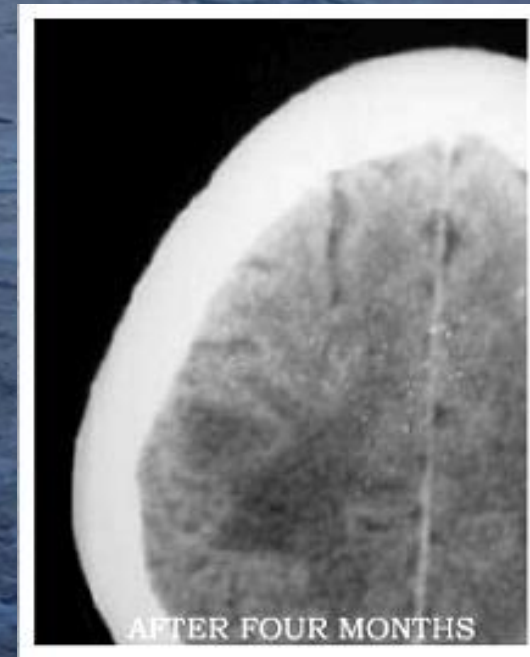
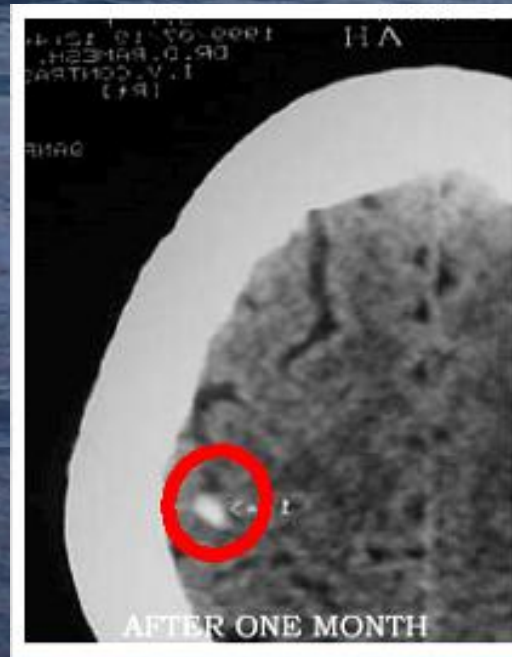
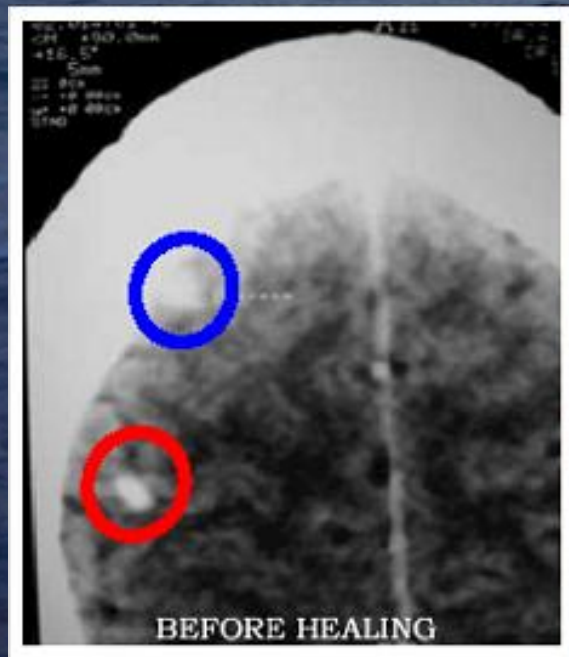
